# MIRECS Documents: Terms of Use

- Agreement between APX and Account Holder
- Account Types:
  - Electric Service Provider
  - Non-profit Wholesale Power Provider
  - Project Account
  - General Account
  - Retail Purchaser Account
  - Qualified Reporting Entity
- Fee Structure
  - Registration fee: One-time
  - Subscription fee: Annual (pro-rated for 2009)
  - Electric Service Provider fee: Based on total retail load served in Michigan

# MIRECS Documents: Fee Structure

## Project Fees:

| Type   | Size          | Registration | Subscription |
|--------|---------------|--------------|--------------|
| Micro  | <40 kW        | 50           | 100          |
| Small  | 40 kW- <1 MW  | 100          | 250          |
| Medium | 1 MW - <10 MW | 350          | 750          |
| Large  | 10 MW ->      | 750          | 1500         |

# MIRECS Documents: Fee Structure

## Account Fees:

| Type                                | Size  | Reg. | Sub. |
|-------------------------------------|---|------|------|
| ESP                                 | > 1,000,000 MWh retail load                       | 750  | 1500 |
| ESP                                 | 100,000 MWh - $\leq$ 1,000,000 MWh of retail load | 350  | 750  |
| ESP                                 | <100,000 MWh of retail load                       | 50   | 50   |
| Non-profit Wholesale Power Provider | n/a   | 500  | 1000 |
| Project                             | n/a   | 250  | 0    |
| General                             | n/a   | 750  | 3000 |
| Retail Purchaser                    | n/a   | 0    | 1000 |
