

MIDWEST ISO RELEASE FORM

Release

This document is a Release ("Release") between the entity identified in the signature block below ("Generator Owner") and Midwest Independent Transmission System Operator, Inc. ("Midwest ISO").

Recitals

WHEREAS, Midwest ISO has entered into an Amended and Restated Services Agreement, dated as of June 1, 2009 (as amended, the "Agreement") with APX, Inc. ("APX") to provide generator-specific information to supply renewable resource tracking systems operating in Midwest ISO;

WHEREAS, Midwest ISO may only provide information to APX as required pursuant to the Agreement for each Generator Owner who has executed this Release;

WHEREAS, Generator Owner is a Market Participant, as that term is defined in Midwest ISO's Open Access Transmission and Energy Markets Tariff accepted by the Federal Energy Regulatory Commission, who desires Midwest ISO to release to APX information in the Generator Owner's market settlement system on energy injections for one or more generating units owned by such Generator Owner; thus, the Generator Owner's consent is required prior to disclosure by Midwest ISO of such information; and

WHEREAS, Generator Owner agrees to consent to such disclosure and to grant Midwest ISO permission to disclose the applicable generator-specific information to APX.

THEREFORE, the parties agree as follows:

1. Disclosure of Generator Data

Generator Owner hereby irrevocably and absolutely consents to and authorizes Midwest ISO providing APX with all of the Generator Owner's energy injection data that is contained in Midwest ISO's market settlement system, except for (1) generators that do not go through a control area settlements process, and (2) customer site distributed generators pursuant to the terms of the Agreement. Generator Owner also agrees to the inclusion of its name and specific generator name or names being listed in Exhibit C of the Agreement; such Exhibit C may also be posted on Midwest ISO's website

2. Release

Generator Owner hereby releases, discharges, and hold harmless Midwest ISO (its officers, employees, agents, representatives, successors, assigns, and anyone authorized by Midwest Independent Transmission System Operator, Inc.) from any and all claims and demands arising out of or in connection with the use, reuse, publication, republication, and editing of energy injection data provided to APX by Midwest ISO pursuant to this Release.

If the foregoing correctly sets forth the understanding and agreement between Midwest ISO and Generator Owner, Generator Owner consents to and authorizes the disclosure by Midwest ISO to APX, its respective affiliates, attorneys, advisors and other representatives, of the Generator Owner's energy injection data solely for the purposes described herein, please so indicate in the space provided for that purpose below, whereupon this Release shall constitute a binding agreement
